Alpha Epsilon Chapter's home is in Oak Ridge. The United States government secretly built the city in 1942. During a time when many cities were destroyed by war, Oak Ridge was created because of war. The schools were established in 1943 by the United States Army to educate children of the workers building and operating the Manhattan Project facilities.

Alpha Epsilon was organized by Xi State President Helen Zuccarello and sixteen members on February 4, 1953. These "Key Women Educators" brought with them talents and gifts as seen, respectively.
