

Nomination for the Tennessee State Order of the Rose

Application Deadline: March 15, 2026. Recipients will be selected based on the greatest number of total points. Each application will be reviewed and points awarded for each qualifying response. For example, if there are multiple occurrences of community service, each one will be awarded a point. Please fill out the application completely and as detailed as possible to ensure your nominee has the greatest chance of being selected.

- This recognition is for members who have made outstanding contributions to chapter and community, but who have not received recognition at the state level through other means. Up to 12 members will be recognized during the Tennessee State Convention.
- The nominee shall have been an active participating member for at least 15 years.
- Only one member may be nominated per chapter.
- A picture of the nominee must be emailed to tndkg.awards@gmail.com, including the nominee's name. The photo needs to be in a jpeg format.
- Honorees are honored at the annual Tennessee State Convention and must register for and attend the convention.
- All parts of the application must be received by March 15.
- Chapters must include a check for \$20 with the application to help defray part of the cost for the Order of the Rose pin guard. If an applicant is not selected, the \$20 will be returned to the chapter. This check must be received by the committee chair by March 15.

In order for a nominee to be considered eligible, all three parts must be submitted and received by March 15, 2026:

1. Completed application via Google form
2. A photo of the nominee in jpeg format, must be emailed to tndkg.awards@gmail.com
3. Check for \$20 payable to Tennessee State.
